Check and Credit Card Payments

The following policy will apply to any payment to NAGA for dues, entry fees or miscellaneous charges for returned checks or denial of payment on credit card remittances. A letter or e-mail will be sent to notify the payer that the check or credit card charge has been denied. The notification will specify that the amount due must be paid by certified check or money order (in U. S. funds) to satisfy the obligation. If a payment is rejected for a tournament entry fee, **the entry will be denied** until the obligation is paid. The member will be placed in "non-member status" until all obligations are satisfied, including a fee of \$ 25.00 U.S. added to all applicable charges of rejected check/credit card.

Late Entries: Entry Deadline: June 30th, 2016. Late entrants are accepted based on availability. They may or may not receive a tournament golf shirt in the size requested or other items ordered before deadline.

Refund Policy: No full refund of fees will be made after July 15th, 2016.
